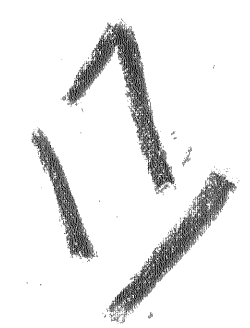


DEDICATION

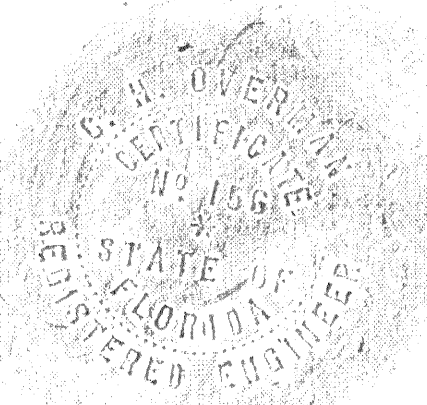

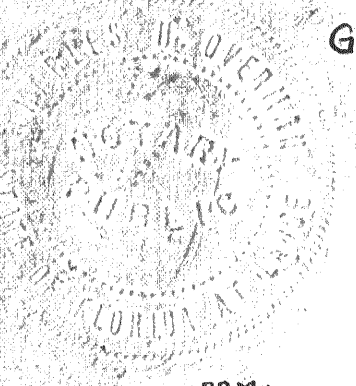
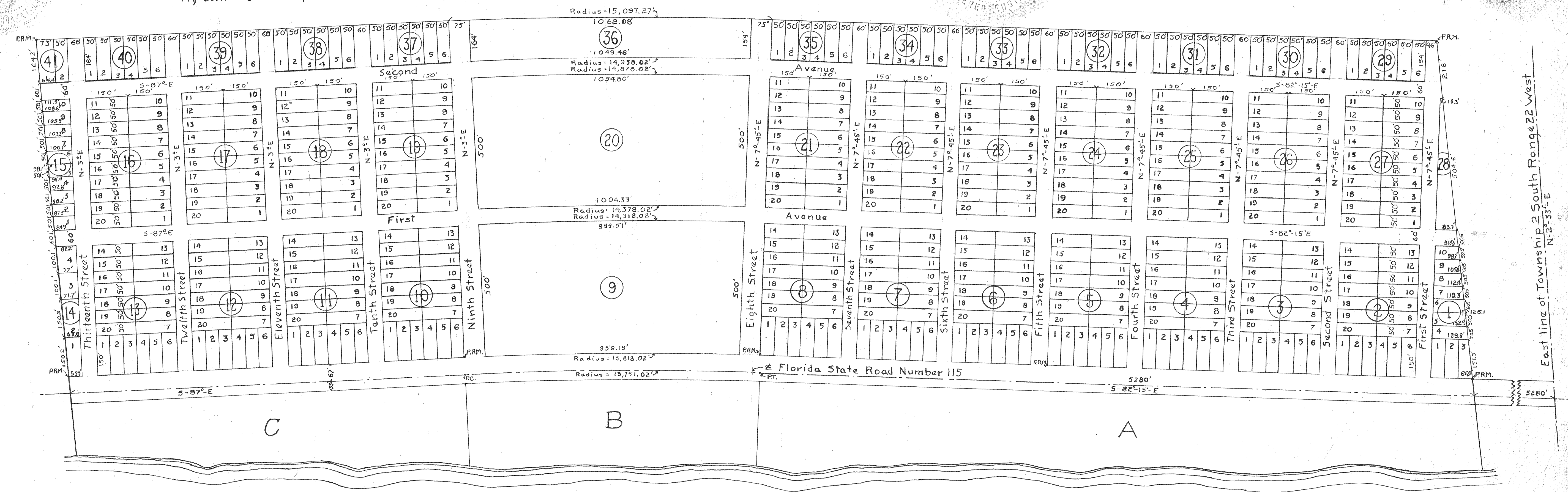
